**SHOW SPACE:** Booth fee is \$400 and is due upon acceptance. Do not send booth fee with application. Each artist is assigned a 10 by 10 booth (no double booths) located on the sidewalk surrounding the Rittenhouse Square Park. There is also a shared 5 foot space between every 2 booths.

**AGREEMENT & WAIVER for 2010 shows**

I understand that by submitting this application, I am agreeing to abide by all regulations and rules and their interpretation by the Board of Directors of the Rittenhouse Square Fine Arts Assoc. (RSFAA). Also, if requested, I agree to remove any artwork or display materials deemed unsuitable by the RSFAA.
